General Meeting
Central Florida Fairgrounds - March 9, 2008

President Linda Tuzzolo called the General Meeting to order at 10:00 a.m. on Sunday, March 9, 2008. Jerry Miller gave the invocation following the Pledge of Allegiance. Linda Tuzzolo welcomed Cliff & Ree Spiller as our newly installed 2nd Vice President.

Linda congratulated all the chapters on a job well done. We feel that our rally was a good value for the money spent to attend. We will be compiling the survey results and will report on them at the May meeting.

A copy of the membership directory was given to all rally participants that wanted one. We hope it will help us promote membership and is being used as a membership tool.

This year was the first year we had T-shirts available. We had 120 shirts ordered and will continue to offer T-shirts again next year. Again, they will need to be pre-ordered. We also plan to have the mystery person again next year.

Jack Caffrey reported on the by-laws which have been revised and are posted on the Website. Each of the Chapter Presidents need to review the bylaws with their chapters. We will discuss

them at the May meeting and vote on them at that time. Jack Caffrey was the committee chairman and he thanked the committee, Jerry Miller, Ron Wacker and Terry Busch for their input. Changes in the bylaws are underlined as a change. Both Doug Formanek and Dick Dodge have reviewed and approved the changes as they meet WIT's needs.

Other Business:
